

May 25th Meeting Highlights



<u>General Updates</u>

The Board approved Resolution 05-03-21 "A Resolution to object to the renewal of a liquor permit of Mark and Francis Mills dba Musical Inn, aka The Cove- Canton, 3941 Navarre Rd SW Canton Township (Liquor Control Permit Number 60189690030, Agency Number 00822

The Board approved Resolution 05-05-21 "A Resolution to object to the consideration on appeal concerning the renewal of a liquor permit for Brick City Lounge, 2820 8th Street NE, Canton Township (Liquor Control Permit Number 095115, Agency Number 00822)."

The Board referred follow up of various concerns related to the operation of the Thirsty Cattle Saloon to township zoning and legal counsel.

Approved a random drug testing policy that encompasses all township employees who drive vehicles on a regular basis, including CTFD, zoning, and any non ODOT licensed Public Works staff. Previously, random testing only occurred with ODOT licensed staff. The Board of Trustees believes this policy helps ensure for the community all employees are operating vehicles free of any influence and promotes the best in safety practices as possible. This is another additional step that can help reduce related insurance premiums for taxpayers as well.

Faircrest St SE will be closed between Cleveland Ave and Central Ave beginning June 1st for 75 days. Crews will be restoring a bridge and there will be no through traffic (detours will be posted). At conclusion of this bridge replacement, a mutual grant request in collaboration with the Stark County Engineer's Office and Canton Township with the Ohio Public Works Commission will result in Faircrest ST SE from Central to Belden and Central from Faircrest and Baum repaved. This grant will save Canton Township taxpayers approximately 74% the normal cost to repave these roads!

Zoning Department

The Board declared the following properties as a nuisance as deemed by the Zoning Director, and ordered them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. 539 Figueroa Pl SE, 4242 Sherer Ave SW, and 4204 Dueber Ave SW all for trash and debris.

The Board approved the Fiscal Officer to sign letter to Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on 22 parcels: 1312424, 1307312, 1303629, 1303630, 1303631, 1380055, 1380054, 1380056, 1312902, 1306616, 1400634, 1315032, 1308938, 1303673, 1303678, 1301591, 1312336, 1305102, 1305101, 1305100, 1307061 and 1307062, totaling \$11,500.00

In a public hearing, the Board approved the reclassification of property for RJAZ Properties, LLC Parcel #10013623 Navarre Rd SW currently split zoned as RR, R-2, B-2 and I-1 to I1 on the 24.3 acres on the west side and B-2 on the 3.7 on the east side (to protect the integrity of the residential portion on Calvin). Prior to the the public hearing, both Stark County Regional Planning and the Canton Township Zoning Commission reviewed the application and approved the application with modification.

A public hearing was set for June 22nd at 6:00 p.m. to consider application CA-3-21 by Larry Bowling at 3650 Cleveland Ave SE currently zoned as B2 requesting reclassification to B3.





Public Works Department



The Public Works Department will be accepting applications for a Full-time Road Maintenance Employee within the Public Works Department. Applicants must have a minimum of a Class "B" CDL drivers license, submit to pre-employment and random drug testing, be insurable to operate Canton Township vehicles/equipment, and be flexible with working hours. Upon review and recommendation from township legal counsel the Board accepted paving bids for 2021 in an amount of \$776,204.80. This approval included the base bid and alternates 2 and 3.

The Board approved the Board President to sign the Memorandum of Agreement Between the Automated Data Processing Board of Stark County, Ohio and the Board of Trustees of Canton Township, Stark County, Ohio for Enterprise GIS Support in the amount of \$3,000. This agreement enhances the practical applications of online mapping systems that can be leveraged by all township departments as well as the interface with the new township automated work order system.

Received an update from the Public Works Director that the capital improvements bid package for Faircrest Park is being put together, will be reviewed by legal counsel, and will be placed for bid in the near future.

Community Center

The Community Center is reopening fully for reservations and other uses effective June 2nd dependent upon any future CDC, Ohio Health, or Stark County Health Department orders. Reservations and deposits can be made directly at the Community Center and credit cards may now be accepted for payment with a use fee passed along to the card holder.
