

September 29th Meeting Highlights

Cares Act Updates

The CARES Act provides assistance for State, Local, and Tribal Governments. Through the Coronavirus Relief Fund, the CARES Act provides for payments to State, Local, and Tribal governments navigating the impact of the COVID-19 outbreak. The CARES Act established the \$150 billion Coronavirus Relief Fund.

TOTAL CANTON TOWNSHIP RECEIVED YTD - \$208,299.72

Some of the items purchased include: medical supplies, cleaning supplies, Chest Compression Systems, laptops and software (to enable remote work capability if that becomes necessary in response to COVID-19), equipment for remote/ distance learning, touch less fixtures, plastic picnic tables for parks, and ULV fogger/ chemicals.

Road News

The 2020 Paving Project has been completed, with 3.57 miles being paved. Total cost for 2020 paving comes to \$497,968.13 and represents utilization of the largest portion of our annual road levy funds. Since the inception of the road levy, 49% of the townships 98 miles have received attention, with 51% remaining. Following the winter season, we will reevaluate roads to determine 2021 priorities.

Zoning Department News

The Board approved the Fiscal Officer to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on 21 parcels: 1315065, 1380055, 1380054, 1380056, 1303049, 1302764, 1307061, 1307062, 1400236, 1308938, 1301444, 1312424, 1307798, 1303629, 1303630, 1303631, 1305244,

1304875, 1304876, 1301591 and 1309394 totaling \$10,850.00.

The Board declared the following properties nuisances as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. Charlotte Ave SE- unlicensed vehicle, 4204 Dueber Ave SW- trash/ debris/ unlicensed vehicle, 2430 17th St SE- no permit pool, 4624 Ridge Ave SE- no permit pool, 3210 Waynesburg Dr SE- no permit deck, 3953 Baum St SE- no permit barn, and 404 33rd St SE- no permit accessory building.

Nuisance property updates:

2347 Prairie College- The clean up efforts from the property owner have ceased, as well as communication. The Zoning Department is working with legal counsel on the next steps to address this nuisance.

3516 Prairie College St SW- An update was received from the Stark County Health Department that a notice was posted on this property deeming the structure as UNFIT FOR HUMAN HABITATION. It was noted that in accordance with section 3707.01 of the Ohio Revised Code, this structure is declared a public nuisance and may not be used for the purpose of human habitation until existing conditions are corrected.
