

December 8th Meeting Highlights

Zoning Updates

The Board approved a resolution to acquire the parcel of real property at 3516 Prairie College SW. This is a nuisance property that has been cleaned up multiple times by the township. The property is tax delinquent and has also been deemed uninhabitable by the Stark County Health Department. The Stark County Landbank Targeted Acquisition Assistance Program (TAAP) is the petitioning entity.

The Board of Trustees conducted a public hearing prior to the regular meeting to consider the application for reclassification of property of 2714 Waynesburg Dr SE from a B2- Neighborhood Business to a B3-Commercial Business. Prior to the public hearing, Stark County Regional planning and the Canton Township Zoning Commission met to review this

reclassification. Both entities recommended denial of this application. After review, the Board made a motion to deny the reclassification.

The Board declared the following properties nuisances as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. 1484 Valentine Cir NW, 1469 Valentine Cir NW, 412 Ironwood Cir SE, Parcel #1400178 on 12th St NW and 3014 Lincoln St E all for trash and debris.

Park News

Canton Township Community Park has been closed for the 2020 season. Surveillance cameras have been completely installed and are fully operational.

Yard Waste Updates

The residential yard waste site has closed for the 2020 season. As of December 8th, \$44,070.00 of the \$45,630.00 grant funds have been exhausted. Final hauling expense numbers are expected by early 2021. (The township expects a final bill in late December for the dumpsters hauled following the site closure).

• A Good Neighbor Award nomination was received by the Board to recognize David & Linda Medley and Mitch Swihart who graciously volunteered their time to daily lock and and unlock Canton Township Community Park from late spring until late fall until park cameras were up and operational. The Board appreciates their efforts to protect the park and will recognize them at the December 22nd meeting.

- The Board received an update that the Stark County Sheriff has scheduled 24 of 64 hours authorized and available for extra patrol work. These hours are fully dedicated to our township.
- Approved \$1,256.97 of work with Intech using CARES Act money to improve the WiFi at the township administration building and out to the Public Works area.
