The Board swore in three new part-time firefighters last night. Welcome Firefighter/ Paramedics Ryan Wells and Joe Kakascik and Firefighter/ EMT Baron Derita to the Canton Township Fire Department family.

#### **New Salt Storage Facility**

As the snow starts to fly, Canton Township will be more prepared than ever to keep our roads clear and safe.

Just in time for winter, our new and more importantly, larger salt shed, is ready to go. Our old salt shed (being





held up by piles of dirt) only held about 400 tons of salt, or enough salt to go around the township 3+ times. If we had back to back snow/ice events or any interruption in our salt deliveries, like two winters ago, we would run short on salt. This new salt dome will hold about 1,200 tons of salt (three times our current capacity), which will better protect the township from potential salt shortages.
