### ***Fire Department News***

The Board agreed to withhold \$15,000.00 from the final payment for the Canton Township new Station 1 to the construction company until exterior landscaping work is completed to satisfaction.

### ***Zoning Department News***

The Board of Zoning Appeals and Zoning Commission are both accepting letters of interest from Canton Township residents to fill an alternate

member seat on each Board. Both alternate seats carry a term through December 31, 2020. The Board declared the following properties nuisances as deemed by the Zoning Director, and ordered them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. Thelma Williamson- 3120 2nd St SE and Christine D. Stephens & Walter D. McGill & Nancy & Steve & Debbie ET A- 4006 12th St NW both for trash and debris.

The Board approved the Fiscal Officer to sign the letter to Stark County Auditor requesting a lien on the tax duplicate for trash and debris removal nuisance assessment on 2 parcels: 1306616 and 1303629 totaling \$4,270.61.

The Board approved the Fiscal Officer to sign the letter to Stark County Auditor requesting a lien on the tax duplicate for board up nuisance assessment on 1 parcel: 1305099 totaling \$446.00.

The Zoning Department has been in contact with the state manufactured home compliance department. They indicated that an inspector would be out to access the nuisance issue with the trailer facing Ridge Ave SE. As the trailer is inside of a trailer park, the township has no jurisdiction over the nuisance abatement.
