### **Partners for Community Success**

The Canton Township Board of Trustees, Canton Local Board of Education and Departments Heads from both entities met for a collaboration session to review current / ongoing, future and other pertinent items that benefit both Canton Township and Canton Local Schools. Some topics included school building projects, township building projects, strategic planning efforts, planned community events, flags and banners project on Route 800. The next collaboration meeting is planned for July 13th at 6:00 p.m. and will be hosted at Canton South High School in the Community Room.

### **Fire Department News**

The Board was updated on CTFD's new station progress and expects construction to be finished by the end of this month with a tentative move-in scheduled for the 1st quarter. Plans are being made to host an employee and public open house with details to follow.

A dispatching agreement with the Stark County Sheriff's Office was approved to take over emergency dispatching for Canton Township. This change in dispatching service will also reduce the number of transfers a caller to 911 would experience as the Sheriff's Office would dispatch calls directly, thereby reducing the amount of time it takes to get help rolling.

## ***Zoning Department News***

The Board declared the following properties nuisance as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. Edward G Stach & Sun Cha- 3115 25th ST SE and Nice City Homes LLC- 1304 Cole Ave both for no shed permit.

The Fiscal Officer signed the letter to the Auditor requesting a lien on the tax duplicate for trash and debris removal nuisance assessment on 1 parcel: 1306035 totaling \$5,169.69. This clean up was a result of the contempt

hearing for the property located at 935 46th ST SW. 29,420 lbs. of trash and debris was removed.

The Board approved a resolution to object to the Brick City Lounge liquor license renewal.

Township Legal Counsel and Zoning Department Representative testified in court on Monday regarding the property located at 3516 Prairie College ST SW. The court ruled that the property owner would be given 30 days to purge himself of such contempt by complying with the court's order. Failure to comply will result in an order allowing Canton Township to take all reasonable steps to abate the nuisance conditions and assess the costs for the same against the tax duplicate.
