The Fiscal Officer was authorized to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/ high grass nuisance assessment on 8 parcels: 1380055, 1380054, 1380056, 1307061, 1307062, 1307312, 1400684 and 1312140 totaling \$4,000.00

The Fiscal Officer was authorized to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for board-up of vacant house assessment on 3 parcels: 1307755, 1309226 and 1306289 totaling \$1,740.00

The Board declared the following 4 properties nuisance as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code.
