The Fiscal Officer was authorized to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/ high grass nuisance assessment on 13 parcels: 1307061, 1307062, 1314939, 1301915, 1305586, 1305585, 1305584, 1305527, 1302764, 1305576, 1380055, 1380054, and 1380056 totaling \$6,050.00
