Zoning Department News

The Zoning Commission is accepting letters of interest from Canton Township residents to fill an alternate member seat. Please send letters of interest via email to l.datkuliak@cantontwp-oh.gov or by mail to Canton Township Board of Trustees Attn: Zoning Department at 4711 Central Ave SE Canton, OH 44707. Appointments will be made by the Board of Trustees.

The Zoning Commission is a quasi-legislative body established by statute and its function is to:

- 1. Establish and amend the Township Zoning Resolution.
- 2. Establish and amend the Official Zoning Map.

The Board approved the Fiscal Officer to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on 14 parcels: 1305099, 1303096, 1303397, 1303398, 1306289, 1306290, 1307024, 1301444, 1303681, 1301591, 1312424, 1315065, 1302002 and 1304458 totaling \$7,900.00

The Board declared the following properties nuisances as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. 519 Pekin Dr SE for trash & debris, 1600 Whipple Ave NW for not obtaining a conformance permit, and 4263 Lincoln St E for unlicensed vehicles.

The Board approved the Resolution to adopt certain text changes to the Canton Township Zoning Resolution to require a zoning permit for any fence or wall; to rename "Skill Games" as "Skill Based Amusement Machines", to require "Skill Based Amusement Machine" operators to be registered with the Ohio Casino Control Commission and to limit Skill Based Amusement Machines, as a conditionally permitted use in Industrial Zoned Districts."

Park News

The Board approved to perform a site survey and geotechnical engineering services in preparation of potential future projects at Faircrest Park.
