

May 26th Meeting Highlights

General Updates

The Canton Township Administrative Office located at 4711 Central Ave SE has reopened to the public with one individual permitted at a time in the lobby. All other township facilities remain closed at this time pending further updates from Govenor DeWine and CDC orders.

Trustees will review the proposed location of an Eagle Scout project by Nathan Cordes that involves the installation of a used flag depository at either Faircrest Park or Fire Station 1/ Community Center property.

The Board approved a resolution establishing a formal process to guarantee the public an opportunity to be heard for public speaks in the event social gathering limits exceed 10 persons at Board of Trustees meetings while social gathering limits are in place.

Application for the position of Full-time Firefighter/Paramedic can be obtained from the Canton Township Fire Administration Office or filled online at our Facebook page and <u>Cantontwp-oh.gov</u>. Completed application must be returned to the Canton Township Fire Administration Office 210-38th St. S.E. Canton, Oh or via fillable form by 3:00 pm June 12th. Any application returned after this date and time shall be voided.

This position will be a shift (24/48) or fill position, working mostly non-standard battalion shifts 50.65 hrs. per week.

- · Probationary Firefighter/ Paramedic wage is \$41,080.00.
- After four years currently \$53,106.50
- All applicants must have obtained the E.M.S. level of Paramedic with Stark County standing orders at time of appointment.
- · Ohio Firefighter II Certification at time of appointment.
- Must have satisfactorily completed a Physical Assessment Test (PAT) within six months
 prior to appointment.
- Must have a valid Ohio driver's license.
- Must have a high school diploma or earned a General Education Development (GED).

Applicants who receive a conditional offer of employment will be "pending" the results of a psychological evaluation process, FBI and BCI results, completion of physical agility test, and Paramedic certification.

The applicant will be responsible, at their expense, to provide a copy of a Federal Background Check (FBI) with fingerprints and Identification (BCI).

After review of applications those meeting the minimum requirements will be contacted for an interview.

Compiled list shall be in effect for the period of 1 year from Board of Trustees approval, with the option of extending the list for another year if deemed necessary by the Board of Trustees.

Parks News

The Board approved electrical work and surveillance camera installation at Community Park, until the cameras are operational the park gate will be closed and opened per park hours.

Zoning Department News

The Board declared the following properties nuisances as deemed by the Interim Zoning Director, and ordered them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. Annette Sutton ETAL- 343 Trump Ave NE for trash/debris.

The Board approved the Fiscal Officer to sign the letter to Stark County Auditor requesting a lien on the tax duplicate for trash and debris removal nuisance assessment on 3 parcels: 1308942, 1400071 and 1314996 totaling \$4,947.77.

The Board approved the Fiscal Officer to sign letter to Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on 8 parcels: 1400684, 1400934, 1303049, 1312336, 1306616, 1307061, 1307062 and 1305226 totaling \$4,800.00

Since April 9th, the Zoning Department has identified 60 properties as high grass nuisance. 21 properties have already been mowed this year by the township. Once mowed by the township, a letter is sent to the auditor requesting a lien on the tax duplicate.
