#### Road News

- Approved a change order to add additional roads to the 2020 road paving plan with Superior Paving. Superior Paving will have until October 8th to execute all street paving per contract.
- Discussed a mutual services contract between Canton Township and the Village of Meyers Lake.

### **Zoning Department News**

The Board approved the Fiscal Officer to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/high grass nuisance assessment on 19 parcels: 1301915, 1380055, 1380054,

1380056, 1307024, 1306289, 1306290, 1303629, 1303630, 1303631, 1400684, 1302896, 1400236, 1307061, 1307062, 1307517, 1307516, 1301444, and 1301591 totaling \$9,550.00.

The Board declared the following properties nuisances as deemed by the Zoning Director, and order them abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance Code. Fredric & Sharron Barclay- 5118 Martin Dr SE and David Workman- 920 Mattie St SE for trash and debris.

### Other meeting news

- Discussed moving forward with two potential township sponsored Trick or Treat efforts. Plans are depending on whether State/Stark Health Department recommendations suggest door to door be held or not.
- Approved Board of Elections to utilize the Community Center as a voting location for township residents this November election. The Board of Elections will notify any impacted residents prior to the election.
- Approved up to \$15,000 in CARES Act dollars to purchase technology to permit staff to be able to have the flexibility to potentially work remotely, if pandemic related scenarios require.
- Approved up to an additional 64 hours of additional dedicated law enforcement coverage with the Stark County Sheriff's Office; coverage would be exclusive to Canton Township.
- Notification approval to AEP for removal of 28 street lights to be removed off township billing and moved to City of Canton billing following audit. Additional approval to submit letters requesting credit for the 28 street lights for a period of 24 months.
