


# January 5th Meeting Highlights

#### **Zoning Updates**

The Board declared the following property as a nuisance as deemed by the Zoning Director, and order it abated per Ohio Revised Code 505.173 and/or 505.86 and/or 505.87 and the Canton Township Property Maintenance

Code. 324 Charlotte Ave SE for trash and debris.

The Public Hearing for CA-2-20 regarding text amendments to the Canton Township Zoning Resolution was recessed and will resume on January 19, 2021 at 6:00 p.m.

3516 Prairie College St SW- The Zoning Department has referred concerns regarding the unfit for human habitation order and whether someone is possibly occupying the home back to the Stark County Health Department, which issued the order to determine enforcement.

The Board approved to move forward with an injunction lawsuit to be filed against 1400 Whipple Ave NW- Trinkets and Treasures regarding an expired conditional use permit to operate a skill games where no action was taken by the permit holder.
