Road Updates

The Board approved to place the expiring road levy renewal on the November ballot. Approval will result in **NO** additional taxes. Approval will permit Canton Township to continue resurfacing efforts of our 98 miles of roadway, which were ALL in need of resurfacing as soon as the levy passed. Without approval to continue this levy, road resurfacing efforts will stop and very little to NO resurfacing work will be done.

The Board approved an agreement to work in conjunction with the Stark County Engineer's Office to explore funding opportunities for replacement of the Faircrest Street bridge as well as resurfacing township maintained roadways as part of that project.

Yard Waste Updates

The grant funded residential yard waste site reopened a month earlier than the previous year with reduced hours. The current invoices for hauling waste year to date total \$15,600.00 vs. a year to date total of \$8,560.00 this same time last year.

The Board approved to move forward with the Community Center restrooms renovation project.

Zoning Updates

The Fiscal Officer was authorized to sign a letter to the Stark County Auditor requesting a lien on the tax duplicate for lawn maintenance/ high grass nuisance assessment on 6 parcels: 1301386, 1400684, 1400934, 1400925, 1314939 and 1302267 totaling \$3,900.00.

Other News

Brent Burrier, Assistant Superintendent Canton City Water Department, was in attendance to update the Board on the connection rate for the new line project, update on funding possibilities for future phases and how current connect rates may impact future plans and the water department received resident feedback regarding restoration efforts where new lines have been installed. He also stated the water department will be celebrating 150 years of service next week.

The Board approved a cooperative agreement with Canton Local School District, which helps facilitate assistance efforts between both entities as well as formalizes an arrangement for usage of the soon to be constructed salt storage facility, at the road department, for storage of salt that will be used on Canton Local property by the school system. This agreement also included some financial assistance from Canton Local School District for use of the salt facility that will go towards construction costs. The next Collaboration Meeting is scheduled for December 10th at 5:30 p.m. and will be hosted by Canton Township.

The Board also approved a resolution to sell the Deville Vacant Lot by sealed bid.
